

“Incitec Pivot Limited RB Sellars Gift Card Promotion”

TERMS AND CONDITIONS

1. Information on how to enter this “Incitec Pivot Limited RB Sellars Gift Card” promotion (**Promotion**) and the gifts form part of these terms and conditions. Participation in this Promotion is deemed acceptance of these and any other applicable terms and conditions (together the **Terms and Conditions**). Any entry not complying with the Terms and Conditions is invalid.
2. The promoter is **Incitec Pivot Limited** (ABN 42 004 080 264) of Level 8, 28 Freshwater Place, Southbank, VIC 3006 (**Promoter**). Telephone +61 3 8695 4400.
3. Entry into the Promotion is open to persons and business who meet the following criteria: (a) are a person who is aged 18 years or over, or are businesses operating in Australia; (b) that own or manage a livestock or hay-growing business; (c) subscribe to the Promoter’s mailing list at groundrules.com.au; and (d) have not previously subscribed to the Promoter’s mailing list (collectively **Participants**).

9. The www.groundrules.com.au webpage is managed by the third party Redhanded Creative Pty Ltd. Fulfilment of the Gift will be conducted by Redhanded Creative Pty Ltd and RB Sellars on the Promoter’s behalf. Participant’s personal information inputted into this web page shall only be used by Redhanded Creative Pty Ltd and RB Sellars for the purpose of this Promotion and shall not be used for any other purposes.
10. The Promoter reserves the right, at any time, to verify the validity of Participants (including a Participant’s identity, age, occupation, place of business, and postal address) and reserves the right, in its sole discretion, to disqualify any Participant who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the Promotion entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
11. If there is a dispute as to the identity of a Participant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Participant.

12. The Promoter's decision regarding eligibility of Participants to receive the Gift is final and no correspondence will be entered into.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any Participant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.

To the fullest extent permitted by law, neither the Promoter nor any third parties involved in running the promotion shall be liable for any loss, damage or injury whatsoever (including direct, indirect and consequential loss or damages) incurred by the participant or any other person as a result of or in connection with the Promotion or the use of the Gift.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability for any personal injury, any loss or damage (including but not limited to loss of opportunity and loss of profits) whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where such liability may arise out of the following:
 - a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
 - b) any theft, unauthorised access or third party interference;
 - c) any participant gift that is late, lost, altered, damaged or misdirected (whether or not after its receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
 - d) any variation in gift value to that stated in these Terms and Conditions
