Terms and Conditions – 2021 Incitec Pivot Fertilisers Spring Pasture Promotion

1. The promoter is Incitec Fertilisers Pty Limited (IPF) (ABN 56 103 709 155) of Level 8, 28 Freshwater Place, Southbank, VIC 3006 (“Promoter”). Telephone +61 3 8695 4400.
2. The promotion is the 2021 Incitec Pivot Fertilisers Spring Pasture Promotion (“Promotion”).
3. Information on how to enter and prizes forms part of the terms of entry. Entry into the Promotion is deemed acceptance of these Terms and Conditions.
4. If there is any inconsistency between these Terms and Conditions and anything else that refers to this Promotion, these Terms and Conditions will prevail.

Who can enter

5.
